



# *Journal of Chiropractic Humanities*

## **Guidelines for Authors**

### **General information:**

Papers submitted for consideration to the *Journal of Chiropractic Humanities* (ISSN 1556-3499) should foster scholarly debate and interaction within the chiropractic profession regarding the humanities, which includes; history, philosophy, linguistics, literature, jurisprudence, ethics, theory, sociology, comparative religions, and aspects of social sciences that address historical or philosophical approaches.

The journal's objective is to fulfill this purpose through careful editorial review and publication of expert work, by creating legitimate dialogue in a field where a diversity of opinion exists, and by providing a professional forum for interaction of these views.

The *Journal of Chiropractic Humanities* invites submission of scholarly papers toward fulfilling these objectives. Categories include:

- **Original Papers:** papers that advance knowledge relating to the humanities. Appropriate references should be included to support statements made in the manuscript.
- **Literature Reviews:** systematic and critical assessments of previously published information on topic areas as stated in the purpose of this journal.
- **Letters to the Editor:** assessments of recently published material in the journal in which the author seeks to clarify or add to the published material, or may seek to create legitimate controversy regarding the topic of debate. Letters to the editor should be no longer than 800 words in lengths and include no more than 10 references.

Email all submissions formatted as described in the instructions below to our online editorial office. Please do not send a hard copy of your manuscript in the mail.

### **Authorship**

The uniform requirements state that authorship credit should be based only on substantial contribution, which includes: substantial contributions to conception and design, or acquisition of data, or analysis and interpretation of data; drafting the article or revising it critically for important intellectual content; and final approval of the version to be published. Authors should meet each of these three conditions. Authorship is not justified by participation solely in the acquisition of funding, generation of concepts, or the collection of information.

Any change in authors after initial submission must be approved by all authors. Additions, deletions, or change of order to the authors must be explained to the editor. The editor may contact any of the authors to confirm whether they have agreed to the alteration.

## **Copyright**

Reproduction of articles either in hard copy or electronically, such as on the Internet, requires copyright permission. Authors may include a link on their own Web site to the JCH Web site with permission from the editor, but may not host any JCH material on a website.

## **Financial Support**

All sources of funding for a manuscript should be declared at time of submission. Authors should also describe the role of the study sponsor(s) and the authors should state if their work was independent of the funders (e.g., the funding was not involved).

## **Redundant Publication**

To prevent researchers and readers from being overwhelmed by redundant material, the JCH does not accept papers that significantly overlap with papers published elsewhere. Whenever a paper submitted to the JCH overlaps by more than 15 percent with previously published or submitted work, authors are responsible for notifying the editor and submitting a copy of those papers with the original manuscript.

## **Duplicate Publication**

Duplicate publication is when the same paper (or a paper that is substantially the same) is submitted to more than one journal. At the time of submission, authors must explain in the cover letter any prior publication of the same or substantially similar paper. Generally, duplicate publication is not allowed.

If the editor learns that a submitted paper has been published elsewhere (in either the same or substantially similar form), the editor reserves the right to reject the paper. At the editor's discretion, the editor may consider no papers by any of the authors for a given period of time and/or may print in the journal or publicly announce that the authors have submitted a previously published article. If the paper is accepted and published before a duplication is discovered, the editor will announce the duplication in the journal or have the authors write a letter acknowledging the duplicate publication, and the editor will notify the authors' employers and/or ethics board at the editor's discretion.

## **Simultaneous Submission of Manuscripts**

Authors may not send the same manuscript to the JCH and other journals at the same time. If the editor learns of a simultaneous submission, the editor may consult with the other editor(s) who have received the submission. The editor may reject it or make this decision in discussion with the other editor(s) involved, and may decide to consider no papers from the author from the authors for a period of time, and the editor will notify the authors' employers and/or ethics board at the editor's discretion.

## **Release of Material to the Media**

Material published in the JCH is not allowed to appear beforehand, in detail, in the media. However, reports may appear in the media after presentation of the material at scientific meetings. Articles may be withdrawn from publication in the JCH if given to the media while in press at the journal.

## **Permissions**

It is the corresponding author's responsibility to secure all permissions and provide these to the JCH editorial office. Permissions include the JCH author form, permission to state names or institutions in the acknowledgements, and permissions from models who are identifiable in figures. Illustrations or content from other publications (print or electronic) must be submitted with written permission from the publisher (and author if required) and must be acknowledged in the manuscript, as delineated by the permission granting publisher.

### **Pre-peer review, and internal review by editors**

To insure that only relevant and appropriate papers are sent to peer review, submitted manuscripts are pre-reviewed for relevance, appropriate submission format, and basic quality before sending out to peer review. Therefore, reasons for early rejection may include: the submission does not meet the requirements as stated in the instructions for authors, the work is of poor quality, or the topic is not relevant to the mission of journal.

### **Review process**

All manuscripts are subject to blind (without author or institutional identification) critical review by experts in the related field to assist the editor in determining appropriateness to JCH objectives, originality, validity, importance of content, substantiation of conclusions, and possible need for improvement. Manuscripts are considered privileged communications and should not be retained or duplicated during the review process. Reviewers' comments may be returned with manuscript if rejected or if strong recommendations for improvement are made. All reviewers remain anonymous.

### **Revisions and resubmissions**

If the authors have been given the opportunity by the editor to make specific changes to a manuscript and return it for further consideration, this is considered a "revision." The manuscript will have the same manuscript number and may be sent out to the same or different reviewers, depending on the needs of the revision. A request for revision does not imply that the manuscript will be accepted. Manuscripts that are revised and returned may still be rejected.

If the authors have received a rejection decision but wish the editor to reconsider the decision, this is considered a "resubmission." A new file will be created, and the paper will receive a new manuscript number. The cover letter must explain that the paper is being resubmitted and substantiated with explanations for why the paper should be allowed to be resubmitted.

### **Acceptance for publication**

Processing of a manuscript for peer review does not imply acceptance to publish, even though the paper may be found to be within JCH editorial objectives. Submissions may receive one of 5 responses: 1) incomplete or not ready for submission, 2) major revision, 3) minor revision, 4) accept, or 5) reject. Aside from rejection for uncorrectable faults, a well-compiled manuscript may also be rejected because it adds little new information to work that was previously published in the literature or addresses a new topic that deserves more in-depth reporting. If the paper is accepted, the authors should not distribute content relating to the article while it is being prepared for publication. It is permissible at this time to refer to this manuscript as "accepted for publication" in a forthcoming issue of JCH; however, it is requested that no further details of the paper, or the research on which it may have been based, be given out in consideration that abridged or inexact versions of research or scholarly work can be misleading.

### **Post-acceptance copy editing**

All manuscripts accepted for publication are subject to copyediting and revision to ensure clarity, conciseness, correct usage, and conformance to journal style. Almost all papers that are accepted require some editorial revision before publication. Authors will have the opportunity to review revisions made during the copy editing process during the reviewing of the proofs. Editors will work with authors to arrive at agreement when authors do not find the revisions acceptable, but the JCH reserves the right to refrain from publishing a manuscript if discussion with the author fails to reach a solution that satisfies the editors.

## **Publication scheduling of accepted papers and proofs**

Authors will be notified when they can expect to receive proofs by email. Authors who cannot examine email proofs by the deadline (48 hours of receipt) should email the editor to designate a colleague who will review proofs. All requests for changes within the proofs are reviewed and either approved or denied by the editor. Authors should email promptly for additional information requests from the journal personnel.

## **Manuscript submission**

Manuscripts are considered with the understanding that they represent original, unpublished work or thoughts, submitted solely to *Journal of Chiropractic Humanities*. All manuscripts submitted to *Journal of Chiropractic Humanities* must be accompanied by a signed copyright assignment form from all authors. The copyright assignment form for all authors must be faxed or emailed at the time of initial submission to (630) 839-1792.

All manuscripts must be sent electronically as a Word document written in English to cjohnson @ nuhs.edu. Images must be scanned at 300 dpi in TIF or JPEG format and emailed as separate image files with the file name being the figure number (e.g., "figure 4").

Order of manuscript contents:

1. Cover letter briefly describing the manuscript, including title, with the statement from the corresponding author of with the intent to submit an original manuscript to the *Journal of Chiropractic Humanities*.
2. Introductory information on first page must include the following items:
  - \_\_\_ the title of the article, that is concise and informative
  - \_\_\_ first name, middle initial, and last name of each author, with highest primary academic degree(s) and names of departments and institutions
  - \_\_\_ name, address, phone number, and email address of author responsible for correspondence
  - \_\_\_ all sources of support (e.g., grants, financial support, equipment, organizations).
3. The second page should include:
  - \_\_\_ a structured abstract of no more than 250 words that succinctly states the objectives, discussion, and conclusions.
  - \_\_\_ key words or phrases: preferably MeSH terms.
4. The following page should begin the body of the manuscript. The manuscript should include references.
5. If figures or tables are used, figure and table locations should be noted (e.g., (figure 1) (table 2) in the text where these items should be placed. Legends for figures and tables should be numbered consecutively and should appear on the last page of the manuscript.
6. References should be listed in the order of citation (in numeric order as they appear in the manuscript) and are in superscript (e.g., bodies of evidence<sup>6,13</sup>)
7. References are formatted according to Uniform Requirement style, which can be found at [http://www.nlm.nih.gov/bsd/uniform\\_requirements.html](http://www.nlm.nih.gov/bsd/uniform_requirements.html)

Note: All accepted submissions are subject to editing. The authors are responsible for all statements made in the article, thus are responsible for evaluating the final copy prior to publication. No extensive rewriting or editorial changes may be made by the corresponding author after the article is typeset. Therefore, manuscripts should be submitted in their final and completed format. Additional information may be requested by the editor to insure compliance with publication standards and policy.

- Consent form to include someone's name in the acknowledgments
